

INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA BY THE INTERNATIONAL COMMITTEE OF THE RED CROSS (ICRC)

The ICRC is an impartial, neutral and independent organization whose exclusively humanitarian mission is to protect the lives and dignity of victims of armed conflicts and other situations of violence and to provide them with assistance.

The ICRC organizes the Hellenic International Humanitarian and Refugee Law Competition. The Competition is organized in partnership with the Hellenic Red Cross and the support of the European Centre of Research and Training on Human Rights and Humanitarian Action of Panteion University, the Greek National Commission for Human Rights and the Greek Council for Refugees.

For the purposes of your participation to the Competition, the ICRC needs to collect your personal data. This includes, your full name, address and contact details, date of birth, information about your studies and your CV and also information related to food constraints (allergies, intolerance, vegetarian/vegan).

By signing this form, you give to the ICRC the consent to:

- Process your personal data contained in the registration form exclusively for the conduct and follow up of the Competition.
- Process your personal data for administrative and logistic reasons such as the arrangement of transportation and accommodation issues and food constraints related to the catering provided during the competition.

The ICRC applies the "ICRC Rules on Personal Data Protection" to its processing of personal data.

By signing this form, you also consent that very limited data will be shared with the judges to the competition in order for them to score your performance. The judges will not keep any of your data, that will remain with the ICRC. Limited access to your data (name and participating Institution) will be also given to the HRC volunteers for the facilitation of the smooth running of the Competition's activities. HRC volunteers will not keep any of your data that will remain with the ICRC.

We wish to inform you that pictures and videos will be taken during the Competition. The ICRC and its partners will use your photos/videos for publicity of the event in the social media, such as their Facebook page and their website.

The personal data we collect from you will be kept for one year, with the exception of photos and videos that will be archived by the ICRC delegation in Athens.
